**Consulting Firms for Engineering Design and Construction Supervision for a fish hatchery
in Stung Treng Province
(FiA-CS024)**

1. The World Bank has financed a US\$15 million funding assistance credit to the Government of Cambodia for Mekong Integrated Water Resources Management Phase 3 (M-IWRMP-3), credit number 5777-KH. This project is the regional World Bank financed Mekong Integrated Water Resources Management Program, which includes Cambodia, Laos, Thailand, Vietnam, and the Mekong River Commission (MRC). The objective of the Project is to enhance Cambodia's institutional capacity and infrastructure to sustainably manage its water and fishery resources in the northeast of Cambodia, and thus more effectively engage in trans-boundary water management. The project will be implemented in the Mekong river basin at the Northeast of Cambodia and the implementation duration of the Project is 5 years (2016-2020).

There are two components under this project of which Component 1 is managed by Fisheries Administration (FiA) as Implementing Agency for supporting the Fisheries and Aquatic Resources Management in Northern Cambodia and requires a Consulting Firm to support FiA for Engineering Design and Construction Supervision for a fish hatchery in Stung Treng where the project area is located.

This is a short-term consultancy service to be performed in 2018. The Consulting Firm will be expected to carry out the assignment with detail tasks included in Terms of Reference (ToR) for a 6-month period after the contract signing. The workplace of the Consultant will be based in FiA Phnom Penh with field work in Stung Treng Provinces.

2. **Minimum qualifications to be quantitatively evaluated (scored)**

The interested consultants will be evaluated based on the qualifications and relevant experiences in regard to the minimum criteria listed below:

- At least 7 years' experience in designing and supervising the construction of medium agricultural buildings, fish hatcheries or similar structures.
- Familiar with the World Bank's procurement guidelines, government bidding procedures for civil works, and social and environmental impact mitigation and monitoring.

3. Interested consultants must submit their detailed documentary evidence indicating their credentials to perform the services (approx. 15-20 pages) include company profiles, core business description, description of similar assignments and experience in similar conditions, qualifications relevant to this field, brochure (if available) and other relevant information.
