

INVITATION TO BID

Fisheries Administration (FiA) The Mekong Integrated Water Resources Management Phase III – Component 1

Wishes to engage a contractor to execute the following Works:
Construction of New Office Buildings for PFiA Stung Treng and Kratie (Including Renovation of Existing Office of PFiA Kratie)

1. The Royal Government of Cambodia (RGC) has received credit from the International Development Association (IDA) toward the cost of **Mekong Integrated Water Resources Management Project (Phase III) – Component 1**, and it intends to apply part of the proceeds of this credit to payments under the Contract for the works shown in the table as follow:

No.	Description	Location
1	Construction of New Office Building for PFiA Stung Treng	Stung Treng Province
2	Construction of New Office Building for PFiA Kratie (Including Renovation of Existing Office of PFiA Kratie)	Kratie Province

2. Construction for both locations is scheduled for **6 months**:
 - The construction of new office building for PFiA Kratie is expected to begin in **April 2019** and completed by **September 2019**.
 - The construction of new office building for PFiA Stung Treng is expected to begin in **June 2019** (or earlier) and completed by **November 2019**.
3. Interested qualified eligible contractors are invited to obtain a copy of the bidding documents free of charge from the address given below.
4. To be considered eligible, a contractor must not be under any notice of disbarment issued by the RGC or the World Bank.
5. To be considered qualified a contractor must:
 - (a) Have completed in the last three (3) years at least two contracts of a similar nature of at least **75%** of the value of the bid.
 - (b) Have cumulative construction turnover in the last three (3) years equal to at least 1.5 times the value of the bid price.
 - (c) The proposed works manager must have at least 3 years of experience in the supervision of works of an equivalent nature and size and no less than one year as a manager.

Documentary evidence to demonstrate the bidder's qualifications must be submitted with the bid.

6. Bids must be delivered to the address given below at or before **March 15, 2019 at 10:00am**. Late bids will be rejected. Bids will be opened in public immediately thereafter at the same address in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person.
7. The Employer shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
8. All bids must be accompanied by a **bid and performance securing declaration** as described in the bidding documents. Any bid not accompanied by one will be rejected as non-responsive.
