The World Bank has approved a US\$15 million funding assistance credit to the Government of Cambodia for Mekong Integrated Water Resources Management Phase 3 (M-IWRMP-3), credit number 5777-KH. The project will be implemented in the Mekong river basin at the Northeast of Cambodia and the implementation duration of the Project is 5 years (2016-2020).

There are two components under this project of which Component 1 is managed by Fisheries Administration (FiA) as Implementing Agency for supporting the Fisheries and Aquatic Resources Management in Northern Cambodia and requires a Kratie National Community Fisheries Specialist to provide advice and support for the establishment, implementation and evaluation of community fisheries (CFi), and by supporting the component implementation management, monitoring and reporting in the project area.

The national consultant will be expected to carry out the assignment with detail tasks included in Terms of Reference (ToR) on full time basis for twenty (20) months period. The workplace of the Consultant will be based in Kratie Province at the Office of Provincial Fisheries Administration (PFiA). The ToR for this assignment can be requested through email address indicated below.

The interested consultant will evaluate based on the qualification and relevant experience in regard to the minimum criteria listed below:

- Education: a minimum of a bachelor degree in fisheries, or natural resources management, or other relevant field of expertise is required.
- Professional Experience: minimum 5 years of experience of community fisheries development and management including some experience in the Mekong region. Knowledge on indigenous people and gender issues is an advantage.
- Language: fluency in English and Khmer language.
- Suitability for assignment.

The selection process will be undertaken in accordance with the World Bank's Guidelines "Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011 and revised July 2014.

The FiA now invites applications for this assignment from eligible, qualified and experienced national candidates. Interested applicant should send their expression of interest by submitting their updated curriculum vitae and cover letter with at least three (3) referees by email and attention to:
