 - ii) Have completed contracts with a total cumulative value equal to at least two times the value of the bid price in the preceding 2 years.
 - iii) Not be under any notice of disbarment issued by the World Bank.
- 5. Bids must be delivered to the address given below at or before 2:30 PM, on March 10, 2020. Late bids will be rejected. Bids will be opened in public immediately thereafter at the address given below in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person.
- **6.** The Purchaser shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
