**JOB ANNOUNCEMENT**

**Full Time Assistant of Fisheries Resources Specialist Based in Stung Treng Province**

The World Bank has approved a US\$15 million funding assistance credit to the Government of Cambodia for Mekong Integrated Water Resources Management Phase 3 (M-IWRMP-3), credit number 5777-KH. The project will be implemented in the Mekong river basin at the Northeast of Cambodia and the implementation duration of the Project is 5 years (2016-2020).

There are two components under this project of which Component 1 is managed by Fisheries Administration (FiA) as Implementing Agency for supporting the Fisheries and Aquatic Resources Management in Northern Cambodia. The project requires an **Assistant of Fisheries Resources Specialist** to assist the Fisheries Resources Consultant and PFiA-Stung Treng.

The **Assistant of Fisheries Resources Specialist** will be expected to carry out the works with detail tasks for 15 months' period. The workplace will be based in Provincial Implementation Team (PIT) Office, Fisheries Administration Cantonment, Stung Treng provincial town.

**Duties and Responsibilities:**

- In coordination with Provincial FiA Cantonment and fisheries resources specialist to collect data from fishers and fieldwork activities to ensure the data and information from fishers are accurate
- Provide technical support to the fishers on recording the data and measurement of fish, following to the technical guidebook
- Entry the data of fishes into the computer system (Spreadsheet)
- Assist in coordination with the Provincial FiA Cantonment and fisheries resources specialist to provide the capacity building to the members of community fisheries committee to implement a system for monitoring and evaluating fisheries
- Coaching the fishers to implement a system for monitoring and evaluating fisheries
- Assist in preparing the progress report of fisheries resources
- Perform other tasks as requested.

**Qualifications and Requirements:**

- A maximum as Bachelor's degree in fisheries management or related discipline.
- 1 - 2 years' experience in fisheries management and data entry
- Usable the Microsoft office applications such Words, Excel and PowerPoint
- Basic understanding of English language
- Willingness to work with communities.
