2. The Fisheries Administration (FiA) now invites sealed bids from eligible and qualified bidders for the Construction of Fish Hatchery in Stung Treng Province, Cambodia. **The construction period is 10 months.**

Procurement will be conducted through National Competitive Bidding Procedures outlined in the Procurement Manual for Externally Financed Projects/Programs, and under the laws and regulations governing public procurement within the Kingdom of Cambodia, in accordance with the Procurement Manual for Externally Financed Project/Programs in Cambodia, revised in May 2012, "World Bank Guidelines: Procurement Under IBRD Loan and IDA Credits revised in January 2011 and in accordance with the Financing Agreement"
4. This invitation is open to all eligible bidders from all areas.
5. Interested eligible bidders may obtain further information from Fisheries Administration (FiA) and at the address below from March 24, 2020 to 21 April, 2020 from 08:00 – 12:00 and 14:00 – 17:00 hours (Cambodia Standard Time), Monday through Friday, except public holidays.
